Call for Submissions

Chiang Mai University, Faculty of Law, Law Review is a student-run legal journal, with the assistance and supervision of the faculty, and is now accepting submission for its Second Issue (Volume 2), scheduled for publication in May, 2017. CMULR looks forward for submissions from lawyers, judges, academia, researchers, experts and students from within the legal community. Submissions can be in the form of articles, essays, notes and comments on legal, social, cultural, political or human rights from a domestic, regional or international relations perspective.

Guidelines for Submissions

CMULR requests that the contributors comply with the following guidelines:

1. Immediately contact CMULawReview@gmail.com: Upon your decision to submit a manuscript for further instructions, guidelines, Thai citation instructions, abstracts and declarations.
2. Word Limit: Word limits, as set forth below, are exclusive of footnotes and citations.
3. Citation Format: The citation format to be used is The Bluebook (19th Ed.), www.legalbluebook.com. In keeping with the same, speaking footnotes are discouraged.

Nature of Contributions

1. Articles: An article must conduct a complete analysis of the area of law, which the author seeks to highlight. It must contain a comprehensive study of the existing law, indicating the absence of law and must contain an attempt to suggest possible changes which can address the issue. An article should be between 3,500-5,000 words.
2. Essays: An essay challenges existing paradigms/norms and provides a fresh outlook to common problems. It is strongly recommended that essays be considerably more concise than articles, in terms of scope and conceptualization. An essay is to be between 2,500-4,000 words.
3. Notes: A note is a relatively concise form of an argument advanced by the author. The focus of a note should be on a relatively new debate or controversy regarding the interpretation or implementation in the law. Notes shall primarily highlight contemporary issues, which need to be addressed, and the authors are expected to offer solutions. Students may submit manuscripts in this section. The note should be between 1,500-2,000 words.
4. Comments: A comment is a critique any on recent/landmark judicial pronouncement or any recent legislation or bill before the Parliament or Congress. The comment should be between 1,500-2,000 words.

Requirements: Contributions should be emailed only to CMULawReview@gmail.com, with the subject of the email: "Law Review Submission: (title of your manuscript)". In your email, please include your full name, primary email address, telephone number, (if a student please provide university information and student number), and signed Declaration of Academic Integrity. All submissions are to be made via email as .docx documents, preferably Microsoft Word 2007 or 2010. All submissions will be double blind peer reviewed. All contributions should be original and should not be simultaneously considered by any other publication. Co-authorship to a maximum of two authors is permitted. CMULR is now open for contributions for publication and the last date for submission for the Second Issue is on or before **December 16, 2016**. Contributions may be considered for publication in the next issue, if necessary.

Compensation: One thousand baht will be awarded to any author whose manuscript is published in CMULR.

Plagiarism: All contributions should be the original work of the contributors. Any plagiarized work will be rejected. "Plagiarism" means failure to acknowledge ideas or phrases from another source. Such source is not limited to published text. Acknowledgement of others' work extends to art work, discussions with another person and/or internet materials.

Indemnification: All contributors, by submitting the papers to the Law Review, agree to indemnify the Chiang Mai University and CMULR from and against all claims, suits, and damages based on any claim of copyright infringement or plagiarism or unauthorized use.

Manuscripts: All articles, essays, notes and/or comments herein are fully at the liberty of the authors.
